# **Stewardship 2022**

From October 1 to September 2022 a total of 1,529 hours have been dedicated to the trapping and removal of feral hogs within the all three, adjoining parks. A noticeable decline in the feral hog population has been noted due to these efforts, however work will continue, with the goal of complete eradication on state park properties.





Prescribed Fire is a necessary and proven way to maintain and enhance the health of ecosystems with state parks. Within October 2021 and September 2022, staff have contributed 1,788.5 hours to the preparation and burning of identified burn units with the Johnson's Shut-Ins/Taum Sauk complex. State parks will continue to burn selected areas on 3-5 years cycles.

### <u>Missouri Department of Natural Resources – Division of State Parks</u>

Missouri State Parks are participating within the Missouri Feral Hog Elimination Partnership alongside agencies including Animal and Plant Health Inspection Services (APHIS) and the Missouri Department of Conservation (MDC). A state park strike team has been established with a goal to increase **trapping/baiting operations on state park land** helping to effect and maintain a decline in the regional hog population until the Feral Hog Elimination Partnership eradicates feral hogs across the state.
