

# **KNOB NOSTER STATE PARK**

## ***PREAMBLE AND MISSION STATEMENT***

**September 2021**

### **HISTORY AND SIGNIFICANCE:**

Knob Noster State Park was originally created by the National Park Service in the 1930s as the Montserrat Recreation Demonstration Area, named due to its proximity to the town of Montserrat. The park was developed to demonstrate how marginal agricultural land that had been disturbed could be reclaimed for recreation and conservation purposes. The area would provide much needed recreational opportunities for those living in Kansas City and the surrounding area; away from possible threats of construction and urban sprawl.

As part of President Franklin Delano Roosevelt's New Deal programs, the newly-elected President signed the Emergency Conservation Work (ECW) Act in 1933. The ECW included several agencies such as the Civilian Conservation Corps (CCC) and the Works Progress Administration (WPA; renamed in 1939 as the Work Projects Administration). The ECW provided relief for unemployed workers and farmers while improving and building new structures throughout the United States. The WPA was responsible for the construction of 110,000 buildings across the nation.

During the Great Depression, the WPA began to work on the area's development. From 1938 to 1941, WPA workers transformed what had been exhausted farm and mining land into the Montserrat Recreational Demonstration Area. Development included four artificial lakes, two organized group camping facilities, service buildings, the caretaker's residence, bridges, a picnic shelter, entrance gates, and the park office. Plans originally called for building two additional organized group camping facilities in the area. However, these were never constructed. In addition, during the course of development 315 acres of trees were seeded and planted, 20 acres of land were seeded with various flora, and around 10 miles of foot trails were constructed. Approximately 200 people (mostly unskilled labor) were involved in the area's development and administration. Though World War II significantly delayed construction, the project was finished in 1946.

On October 10, 1946 the Montserrat Recreational Demonstration Area became part of the Missouri State Park system and was renamed Knob Noster State Park for the nearby town. Knob Noster State Park is the only park in the system developed solely by WPA workers and still has many of the rustic buildings. One of the organized group camps and five other structures were added to the National Register of Historic Places in 1985; the entirety of Camp Shawnee is now considered a Historic District.

The park is located in the Osage Plains area of the state, which is dominated by historic prairie plains. Clearfork Creek, which meanders through the park, has had a great influence on the landscape characteristics. The area surrounding the creek is dissected and hilly with a wide

corridor of trees. The woodland structure and old growth post oaks bear testament to this landscape being historically the matrix between prairie, savanna, and woodland. Today, after many years of regularly occurring prescribed fire, Knob Noster State Park harbors great examples of this historic woodland interface.

Knob Noster State Park offers numerous resources to park visitors. Cultural resources that can be found at Knob Noster State Park revolve around the WPA structures throughout the park. These structures reflect the rustic architectural style for which the National Park Service is known.

Although most of the park had been extensively farmed and/or strip mined prior to becoming public land, there are several areas of natural resource significance. These areas include Pin Oak Slough, Christopher Woods, and Clearfork Woodland. Pin Oak Slough is a recognized Natural Area that is home to many wetland flora and fauna. Christopher Woods is the largest contiguous tract of old oak and hickory forest in the park. Clearfork Open Woodland is one area of the park that is maintained through prescribed burns to restore the open woodland that would have been present in the park area prior to European settlement. Other managed areas include Opossum Hollow Woodland, North Loop Grassland, Kiosk Grassland, and Clearfork Grassland.

Recreational resources that can be found at Knob Noster State Park include a family campground with sixty-two campsites, a special-use camping area that can accommodate two hundred people, two organized group camps that will each accommodate approximately one-hundred fifty people, and two pack-in camp sites on the McAdoo Trail system. The park also offers seven trails for hiking for a distance of nearly 19 miles. All trails are open to hiking, while the McAdoo Trail system is open to equestrian users and the Opossum Hollow Trail is open to bicyclists. The park also offers lake fishing, ball courts, kayak rentals, and horseshoe pits. There are three open shelters available by reservation or on a first-come, first-served basis.

Special management responsibilities at Knob Noster State Park include a lease with Whiteman Air Force Base. The lease is on a 50-year renewal period, which started in 1955 and was renewed again in 2005. The base leases the land for use as a golf course (Royal Oaks Golf Course). The park is also impacted by the close proximity of Whiteman Air Force Base due to frequent use by visitors to the base. Knob Noster State Park also has multiple entrances from State Route DD, running through the center of the park. The park is also located adjacent to State Route 23.

#### **MISSION STATEMENT:**

### **MISSION STATEMENT**

The primary mission of Knob Noster State Park is to preserve and interpret the unique flora, fauna, and natural features created by the Clearfork Watershed; to preserve and interpret the cultural landmarks credited to the 1930's development of Montserrat Recreational Demonstration Area; and to provide safe, healthy, enjoyable outdoor recreation opportunities.

### **INTRODUCTION**

Located in eastern Johnson County, west of Knob Noster and Whiteman Air Force Base, Knob Noster State Park exemplifies years of rehabilitation and restoration efforts turning this once disturbed landscape into a recreational area. The park's natural environment is greatly influenced by Clearfork Creek, supporting dissected and hilly corridors of dense second and third growth timber. Notable habitat found within the park's boundary include old oak and hickory woodlands, grasslands, wetland, oxbow slough, and lakes.

Knob Noster State Park still displays many of the rustic buildings originally built by the Works Progress Administration (WPA), reflecting the simplistic architecture which the National Park Service is known for. In 1983, the Camp Shawnee Historic District and five non-contiguous sites were nominated to the National Register of Historic Places. The five sites include the entrance portal, the bridge on the entrance road, the warehouse and repair shop, Lake Buteo dam and spillway, and the stone restroom near the WPA shelter.

### **SITE GOALS**

- Preserve the natural and cultural resources located within the park's boundaries;
- Provide recreational opportunities and public use facilities compatible with the park's mission, resources, and public needs;
- Provide adequate orientation and interpretive facilities to enhance visitor experience;
- Provide administrative support facilities to ensure successful operation and maintenance of the park.

## INTERPRETIVE THEMES

- The unique flora, fauna, and natural features created by the Clearfork Watershed;
- Cultural landmarks credited to the 1930's development of Montserrat Recreational Demonstration Area;
- Pre-park settlement and reasons for development into a park;
- Connection to Warrensburg, Knob Noster, and Johnson County, as a whole.

## SITE STRUCTURES

Knob Noster State Park encompasses eighty structures, forty-eight of which are considered historic and thirty-one are on the National Register of Historic Places; the majority being built in the 1930's by the WPA.

## DEVELOPMENT OBJECTIVES

To best support preservation and interpretation efforts, development objectives should be carefully considered, ensuring they are compatible with the park's significant natural, cultural, and recreational resources.

## **Spirit Trail**

The continuation of the Spirit Trail is to be constructed from Knob Noster State Park's western boundary, extending east to the park's entrance at 871 RD, near the HWY DD/Route 23 intersection; providing connectivity from Whiteman Air Force Base to Warrensburg.

## **Camp Shawnee Historic District**

Due to the lack of a pool, user preference for Camp Bobwhite, and being "too spread out", usage of Shawnee Group Camp has decreased over the years. In an effort to increase attendance and revenue, Shawnee Group Camp is to be designated as a dual-use area (lodging/day-use). This designation will enable guests to rent individual camper cabins as well as facilities for group events, and will open the area to regular day-use.

## **McAdoo Trail Connector**

A connector trail is to be developed from the Shawnee Group Camp to the McAdoo Trail, providing equestrian access to the lodging/day-use area.

## **Special Considerations**

*Natural Area:* The area southwest of Camp Bobwhite (Christopher Woods) and northeast of the Clearfork Lake (Clearfork Bottom) have resource characteristics potential for natural area designations.

## **PROJECT PHASING**

1. Continuation of the Spirit Trail east through the park.
2. Designate Shawnee Group Camp as a lodging/day-use area.
3. Provide equestrian access to Shawnee Group Camp.

Resource and environmental clearances will be required before on-site modifications and development occur.

## **PLANNING AND RESEARCH GOALS**

- Update and/or completion of the General Management Plan.
- Continued documentary research and exploration of park's natural and cultural resources.

## **ACQUISITION UNITS**

If offered, acquisition of adjacent property may be pursued only through willing sellers or donors. To be considered, units should enhance the mission of Missouri State Parks through one of the following categories:

- Resource preservation and protection

- Recreational access and opportunity
- Management facilitation



# KNOB NOSTER STATE PARK





The horses are constantly causing damages to the trail. Additional pack-in sites on Opossum Hollow trail. Open the Special Use Area up to walk-in camping. Remove the golf course!! How is this a natural resource? Informational kiosks at new locations like the natural area/special use area. Update the current kiosks! One is destroyed from squirrels. Update the Visitor Center. The displays are the same from the 90's! Outdoor classroom for school groups and programming would be great. What is going on with Camp Shawnee? It looks run down and is a unique cultural resource. Money should be appropriated to restoring it! If the group camp isn't being used as such, it should be used as something else. Like renting the cabins/pods out. Add cook grills to the cabin areas and treat it like a campground. Bobwhite needs AC added to the cabins and dining hall. We need a disc golf course!

CDP Survey #1 Results (2020)**








### Continue Spirit Trail east through the park
