Summary The Lizzie McLagan House, at 549 E. Argonne in Kirkwood, St. Louis County, is a two story Italianate style house with an irregular plan and a tall square tower. Constructed ca. 1863, the highly intact house is a good example of Property Type B. Italianate Houses, Subtype, Italian Villa. It meets the registration requirements for that property type set forth in the MPS Cover document "Historic Resources of Kirkwood, Missouri." Typically Italianate features include an irregular floor plan, multiple, low-pitched roofs with wide, overhanging eaves, cornice brackets, and wide frieze boards at the main eave lines. A three story square tower with a heavy bracketed cornice dominates the facade; that feature, paired with the irregular massing, is characteristic of the Italian Villa subtype. The house also has wood siding designed to mimic cut stone, complete with staggered quoins on most corners. The tower has paired, round-arched windows; the other windows of the house are flat-topped, and several of those have pedimented lintel pieces. A one-story front porch is set off-center on the facade; it has slender square posts and scrolled brackets. The house is set back from the street on a relatively large lot. The only other resource on the property is a small modern garage which is set near a back corner of the property; the garage is a non-contributing building. The McLagan House retains a high degree of integrity in the areas of design, materials, workmanship, setting, location, and association. It is immediately recognizable to its period of significance, which corresponds to the construction date of ca. 1863.

Elaboration: The Lizzie McLagan House is a large, highly intact example of the Italianate style, with many design features which were popular nationwide, as well as a few which were more typical of Kirkwood. It is one of the more elaborate examples of the Italianate Residences property type in Kirkwood, employing the distinctive square tower which defines the Italian Villa subtype.

The McLagan House faces south onto East Argonne street, and has an irregular floor plan with multiple rooflines. Onto a gabled ell form, flat-roofed, polygonal bays have been added on the first story of the south gable-front wing, as well as on the west elevation. This, combined with rear additions, the tower, and other decorative features, creates a complex form. The tower is centrally located along the facade, in the "L" formed in the junction of a gable-front-and-wing. The tower projects an additional story above the rest of the house, and has a low-pitched hip roof and a wide bracketed cornice. The remaining gable roofs are also low-pitched, with gable end returns and wide, overhanging eaves. Paired brackets adorn a wide frieze board on all the roof eaves of the original portion of the house, with dentils in between.

The one-story, flat-roofed front porch is set within the "L" of the gable wings, and is open under the tower portion. The porch was replaced in 1976, and complements the Italianate house. The porch has slender square porch columns, with Tuscan-type capitals and impost blocks supporting an entablature with dentils and brackets. A second story balcony porch above has a jig-sawn, Eastlake influenced balustrade. The same type of decorative balustrade tops the one story polygonal bays.

Very tall (to the floor), narrow paired windows provide access to the second story balconies

above the one story bays. These windows are one-over-one, double-hung wood sash, and have molded pedimented crowns. The pediments of all the gable wings of the original portion of the house, as well as the top of all sides of the square tower, have small, circular attic windows. The three windows in each bay are double-hung, with a single sash below and geometric pattern of multiple panes above. The third story of the square tower has tall, very narrow one-over-one, double-hung sash windows with round-arched tops. All other windows on the original portion are two-over-two, double-hung wood sash, with wood surrounds with low-pitched, integral pediments above. The front entry is centrally located, under the square tower. Just east of this entry are two additional glass doors, with transoms above, which also provide entry from the front porch into the house.

There have been multiple extensions of uncertain construction dates to the rear (north) elevation, which are one- and two-stories, with lower hipped and cross-gable roofs. All but the northern-most addition have the same type of wide, shiplap siding and corner quoins used elsewhere. The northern room is clad with narrow wood clapboards, and has a recessed rear entry on the north.

The large lot, nearly two-thirds of an acre, has mature deciduous shade trees enframing the house. A concrete walkway leads straight from the street to the front door. A small frame garage with narrow weatherboard siding sits near the northwest corner of the lot. The garage, which is less than ten years old, is non-contributing. A paved parking area is at the rear of the house.

The McLagan house serves today in its original single family function, and is in excellent condition. It is a highly intact example of the Italian Villa subtype of the Italianate Houses property type, and appears today very much as it did when new. △

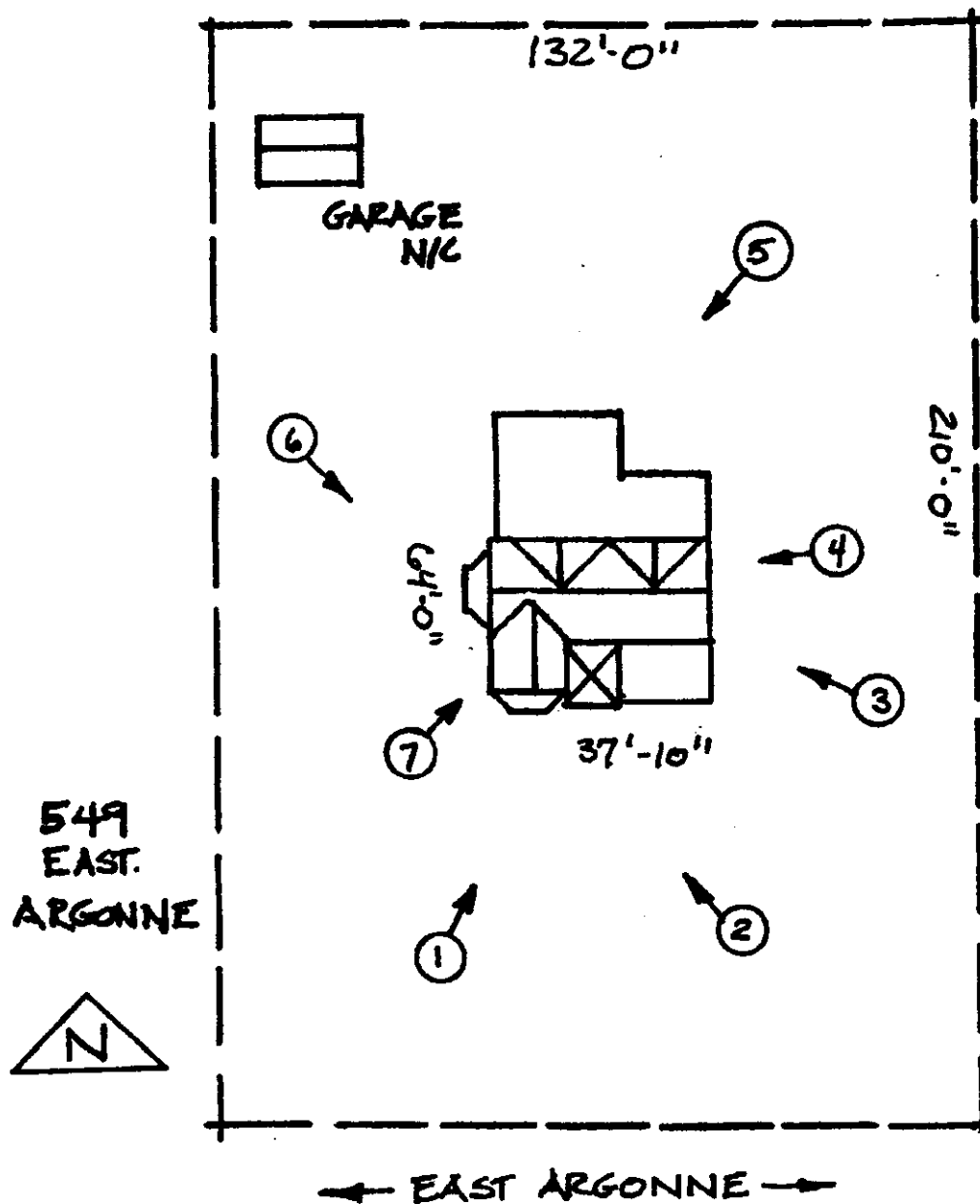

Summary The Lizzie McLagan House, 549 E. Argonne, is significant under Criterion C in the area of ARCHITECTURE. Constructed ca. 1863, the house is one of the largest, most refined examples of the Italian Villa subtype of the Italianate Houses property type in Kirkwood today. The house meets the registration requirements for that property type set forth in the MPS Cover document "Historic Resources of Kirkwood, Missouri," and falls under the context "The Creation of Kirkwood, a Planned Railroad Suburb--1851-1864." Identifying features of this property type found on the McLagan house include multiple low-pitched roofs with widely overhanging eaves and paired decorative brackets, wood siding designed to mimic cut stone, and an irregular floorplan. Those features are all typical of Property Type B.: Italianate Houses. The tall square tower of the facade, paired with an irregular plan, mark this as an example of the Italian Villa subtype. This house represents an early, elaborate example of the style, and exhibits many characteristics common to the Italianate houses of Kirkwood. It was built between 1863 and 1876, for Lizzie McLagan, and has seen few alterations of note since then. The period of significance for the property corresponds with its construction date of ca. 1863. The house is in excellent condition, and exhibits a high degree of integrity of location, setting, design, materials, workmanship, and feeling.

Elaboration: The McLagan house is an elaborate, highly intact example of the Italianate House property type.¹ This is one of the oldest houses which is sheathed with wide, shiplap wood siding and wooden quoins which emulate cut stone. The three-story tower, paired with irregular massing, mark this as an example of the Italian Villa subtype. The delicately rendered tower of this house is one of the most impressive such features found in Kirkwood today. That level of styling is not restricted to the tower; overall, this is one of the most elaborately styled Italianate houses in Kirkwood today.

This property was originally part of forty acres conveyed to Lizzie McLagan in 1863.² The 1878 county atlas map shows that by that time, this house had been built, and the forty acres had been subdivided, with Lizzie McLagan retaining ownership of a smaller parcel which included this house. The next year, McLagan sold the property to Agnes and Charles Black.³ Charles Black was a newspaper publisher who established the Clayton Argus in 1887. That paper had a section called the

“Kirkwood Argus” that was devoted to Kirkwood news.⁴

In 1907, the property was sold to Ethen Allen Taussig. Mr. Taussig had been a primo busso with the San Carlo Opera Company in London. He attended the Royal Academy, where he met his prima donna wife, who also sang with the San Carlos. The Taussigs had one son when they moved to Kirkwood. After the arrival of two more children, they enlarged the house at the rear by adding an upstairs and a downstairs room.

The house was later purchased by the Kirkwood Historical Society, and operated as a museum, under the name the “History House.” It has since been returned to single family use, and appears today very much as it did in the 1800s. It exhibits a high level of integrity and craftsmanship, and is one of the largest, most elaborately styled Italianate Houses in Kirkwood today. □
