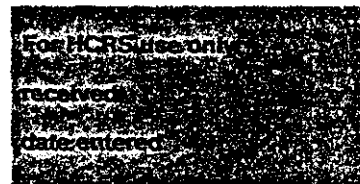

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The George B. Peck Dry Goods Company Building, 1044 Main Street, in Kansas City's Central Business District is an example of "Commercial Style" architecture with classical decorative elements. The building is located on the sloping corner of Main and Eleventh Streets. The frontage on Main Street is approximately 58 feet and 130 feet on Eleventh Street. This eleven story rectangular building has its main entrance on Main Street, facing east.

Exterior

Construction Materials and Colors

The first story on the main facade and partial south facade consists of polished marble, small black tiles and reinforced concrete. The second and third story have been covered over with Indiana limestone and granite. The remainder of the building consists of ivory colored brick, red brick and enameled terra cotta.

East (main) Facade

The first floor of the main facade has two entrances. One is a recessed single panel door located at the northern section of the east facade while a single light panel two door entrance is located towards the southern end of the facade. Large glass display windows are located between the entrances. Surrounding the display windows at the extreme north and south end is marble. Small black tiles cover the remainder of the area. The second and third floor on both the east and south facades have been covered over with Indiana limestone and granite. The fourth through the ninth floors consist of one-over-one double hung recessed paired sash windows separated from each floor by a paneled brick spandrel. On the tenth floor are triple one-over-one double hung recessed sash windows. The entire set of windows are framed by a segmental arch terminating with a cartouche above the tenth floor. Terra cotta foliage swags run above the tenth floor windows and visually support a decorative string course and drip mold. The eleventh floor contains one-over-one double hung recessed rectangular frame sash windows in groups of threes. Each set of windows are separated by a decorative terra cotta rectangular motif. A terra cotta keystone crowns each set of windows. Above these are decorative terra cotta rectangular panels with a criss-cross design pattern. An ornate decorative projecting cornice tops the facade. Antefix are located at each corner of the roof line of the facade.

South Facade

The south facade is almost identical to the east facade. However, the windows on the south facade are in sets of threes rather than in pairs as on the east facade, and the extreme western bay of the south facade contains only a single window. The first floor display windows on this facade have been covered over with either murals or a louvered covering, and a recessed double door is located at the extreme western end of the facade.

West (rear) Facade

The lower floors of this facade are brick covered over with cement. The upper floors are brick with several two-over-two double hung rectangular sash windows. In the upper section is a wall graphic signage of the Peck's Dry Goods Company. At the southern most section of the roof line is the ornate cornice return from the south facade.

North Facade

A good part of the north facade is obscured from view by the Macy's Department Store building next door. The only section of the north facade that is visible is that of the ninth, tenth and eleventh floors. This area is brick with stone trim which visually creates rectangular pattern areas. Several two-over-two double hung sash rectangular windows are located on this facade. The cornice return can be seen along the roof line near the eastern end of the facade.

Interior

The interior of the building at this time consists primarily of two shops on the first floor and storage and vacant space on the remaining floors.

Alterations

1. Recessed entrance on eleventh street and major interior modernization. (1935)¹
2. Second and third floors covered with Indiana limestone and granite. (1950)²

Condition

The building is in fair to good condition.

Site

The building is located at the northwest corner of Eleventh and Main Streets. To its immediate north is Macy's Department Store, to its south the new City Center Square office building, to its west a parking lot and other commercial structures and to its immediate east is Harzfeld's, a women's apparel store.

STATEMENT OF SIGNIFICANCE

The George B. Peck Dry Goods Company Building, 1044 Main Street, is significant as one of the few remaining early dry goods company buildings that anchored the heart of the retail district in downtown Kansas City.¹ It is further significant as a fine example of "commercial style" architecture with exceptional classical elements.² The building was designed by the prominent Kansas City architectural firm of Root and Siemens in 1914.³

Historical Data

George B. Peck (1863-1906) from early childhood was interested in the wholesale aspect of the dry goods business. While in New York Mr. Peck met John Doggett who was organizing a dry goods business in Kansas City. Mr. Peck became interested in Mr. Doggett's store and bought stock in the company and came to Kansas City in October 1889.⁴ In 1894 Mr. Peck was elected vice-president of the Dogget's Dry Goods Company and four years later in 1898 bought Mr. Doggett's interest in the company.⁵ In July of 1901 the company's name was changed to George B. Peck Dry Goods Company.

Mr. Peck was considered an outstanding and progressive merchant. Many of his innovative policies, such as providing schooling for the "cash" boys and girls and other clerks, continued throughout the subsequent growth and development of the business. The George Peck Dry Goods Company was for many years considered to be one of Kansas City's leading department stores. It continued operation in its present location for over 70 years, closing in early 1964.

Root and Siemens

The firm of Root and Siemens was composed of Walter C. Root (1859-1925), brother of the famed Chicago architect John Welborn Root, and George Siemens (1864-1951). Root and Siemens formed their partnership in 1896.⁶ This partnership lasted until Root's death in 1925.

This firm was one of the most active architectural firms in Kansas City. They designed many residences, apartments, churches and commercial structures. Perhaps one of their fine works in Kansas City is the Scarritt Building and Arcade, listed in the National Register of Historic Places.


