Robertsville State Park Mission Statement

Robertsville State Park mission is to preserve its natural and culturally unique features, and provide interpretation and recreation of the site. Preservation includes existing high quality bottom land forest, riparian and river systems as refuge for wildlife and native flora. The park will also provide natural and cultural interpretation and recreational opportunities and facilities for campers, boaters and river users, hikers, walkers, bicyclists and wildlife observation.

Park Description:

- > 1,224 acres of woodland and bottomland forest
- ➤ Robertsville offers 2 hiking trails, walking, biking, fishing, camping with electric and basic sites, playground, and picnic areas

Brief description of the park/site history

- About 3,000 acres was originally owned by the Roberts Family starting in 1830 when they moved here from Virginia.
- Mr. Edward James Roberts and his wife Ann Robertson worked with family farm and produced many goods with tobacco as a primary crop
- Edward James Roberts was the largest tax payer in Franklin County and was Robertsville's first post master, along with other roles he filled in the community.
- In 1950, the descendants of Edward James sold it and it was privately owned until the property was purchased by the Department of Natural Resources on April 10, 1979. It was developed until it was officially dedicated on May 10, 1989.
- > Total Visitation for 2022 is 117,691, 2021 was 141,863 and 2019 was 109,972)
- Total camping units for 2022 is 3,355 (total camping units sold for 2019 was 2,455)

➤ Natural and Cultural features that make your park/site stand out: Robertsville Cemetery, African American Cemetery, Woodland and Bottomland forest, Heron Rookery, prescribed burning, boat ramp, Meramec River


