<ul> <li>A copy of the Volunteer Activity Consent and Parental Approval Form must be given to the park or site for each volunteer under the age of 18.</li> </ul>					
Vol may con	• The Division of State Parks accepts the service of all volunteers with the understanding that such service is at the sole discretion of the division. Volunteers agree that the division may at any time, for any reason, decide to terminate the volunteer's relationship with the division. Volunteers may at any time, for any reason, decide to sever the volunteer's relationship with the division. Notice of such a decision should be communicated as soon as possible to the volunteer's park contact. At any give time, the Division of State Parks may approve, deny or modify any volunteer's activity.				
• Gro for:	Group volunteers must identify a group contact who is responsible for the safety and well being of group members. This person is responsible for:

2.	Ensuring all volunteers under the age of 18 are accompanied by	a responsible adult,

4.	4. Ensuring all volunteers adhere to department, division, and park rules and guidelines,				
5.	Ensuring that all volunteers support the mission of the Missouri D	epartment of Natural Resources and	the Division of State Parks,
