



HOW OFTEN DO YOU VISIT THIS HISTORIC SITE?




WHEN YOU VISIT THIS HISTORIC SITE, WHO USUALLY JOINS YOU?






- **Guided Geology & Rock Hunting Tours** Expand on the rock collection events by creating designated areas for visitors to learn how to identify and collect minerals safely, with expert-led tours explaining the geology of the site. **Mine-Themed Adventure Playground** A play area designed with mining-inspired structures, like tunnels, rock-climbing walls, and pulley systems that mimic the old mining operations, making it fun for younger visitors while educating them about the site's history. **Heritage Trail & Interactive Exhibits** A walking trail with historical markers, immersive audio stations, or augmented reality experiences that transport visitors back in time to see how the mine operated. **Dark Sky Viewing & Nighttime Tours** Since old mines often have limited light pollution, incorporating stargazing events or lantern-lit historical tours could create a unique nighttime experience. **Hands-on Historic Workshops** Workshops that allow visitors to try traditional mining techniques, refine minerals, or even craft jewelry from rocks collected on-site, providing both education and engagement.




- 1. A little more shade by the parking lot would be great. The first time we brought our twins, they were probably just over a year old, and having a shady spot to have snack would have been helpful.

- 2. A small theater: Educational Films Short, dynamic documentaries covering local geology, mineral formations, and mining heritage. Interactive Storytelling Themed presentations featuring reenactments or narrated histories from past miners. Virtual Mine Tours A cinematic experience taking visitors deep into the mine's past with 3D visuals. Guest Speaker Series Occasional talks by geologists, historians, or former miners to bring real-world expertise into the space.
- 3. Add more ranger led tours to areas closed to the public or find ways to open more areas.
- 4. Adding labels or reading plates to each building that gets talked about in the tour. Some people like to read the info instead of hearing it.
- 5. All good.
